Terms & Conditions



Upon registration for any SwissAAA event, the participant is declaring the correctness and his or her consent to and acceptance of the following terms and conditions.

If in doubt, the participant should discuss the matter with SwissAAA and seek prior explicit approval of his or her participation.

1. Registration

- **1A)** There are no objective reasons whatsoever that would inhibit me from being trained in the use of firearms. Such reasons can include for example a criminal conviction or an ongoing criminal investigation, be it in Switzerland or in any other country.
- **1B)** There are no known health deficiencies (including mental disorders or illnesses) that could possibly limit my ability to safely handle a firearm at all times.
- **1C)** I have adequate private liability and medical insurance including accident coverage. The liability insurance has to include a minimum coverage of (or equivalent to) CHF 5'000'000.-
- **1D)** SwissAAA can demand verification of the above information as a condition for my participation. In case of false information on my part, SwissAAA can revoke my right to participate with immediate effect and there will be no basis for any kind of claims against SwissAAA such as for example for any refund (partly or fully) of already paid participation fees.

2. Indemnity

- **2A)** I acknowledge and confirm that my use of the facilities and premises will be entirely at my own risk and I hereby agree to abide by the rules of the facility and the orders of the instructor or range officer which I declare to be fully binding upon me.
- **2B)** I herewith indemnify and shall keep indemnified SwissAAA, its employees, members, trainers, agents, partners or servants and hold each of them harmless from and against all and any claims, loss demands, liability, cost and expenses of whatsoever nature (including legal cost) which may be brought against SwissAAA and the aforesaid persons by any person whomsoever by any act or omission of whatsoever nature and whether amounting to negligence or otherwise on my part and/or breach by me of any of the applicable range rules and/or use of the training facilities and/or premises.
- **2C)** I acknowledge that I will have no claims whether for damage or otherwise (and whether in derelict or contract) against SwissAAA or any of its employees, members, trainers, agents, partners or servants arising out of injury or loss of life and/or property damage and whether caused by the negligence of SwissAAA or any of the aforesaid persons, or as a result of any defective firearm or ammunition having been issued to me and I herewith irrevocably waive and abandon all such claims. I further confirm that this waiver will be binding on my estate, executors, dependants or assignees and that SwissAAA and the aforesaid persons are only obliged to exercise a reasonable duty of care towards me.

3. Cancellation and Refund

- **3A)** All registrations and corresponding payments are deemed definitive. Cancellation by the participant with partial or full refund is only possible for reasons of 'force majeure' such as e.g. grave illness or accident. Corresponding proof will have to be presented such as for example medical certificates or police records that clearly show that the participant could not anticipate the situation and he or she is prevented from participating beyond any doubt. If and to what amount a refund is granted remains in any case the sole decision of SwissAAA and a refund cannot be claimed in any way and for any reason whatsoever.
- **3B)** Cancellation by SwissAAA is possible at any time and with immediate effect, specifically for violation of safety rules or for gross misconduct such as for example: posing a safety risk to oneself or any other person or demonstrating gravely undisciplined behavior such as for example disobeying the orders of the instructor or range officer. In any such case, no refund whatsoever is possible.
